Pray Haringey is a Christian charity serving children, families and communities, registered in the England and Wales (This Privacy Notice explains what to expect when Pray Haringey collects and uses your personal information. OUR PROMISE

Pray Haringey is committed to respecting your privacy and ensuring the personal information you have entrusted to us is held securely. We will process personal information in accordance with the General Data Protection Regulation and the Privacy & Electronic Communications Regulations 2003.

HOW WE COLLECT PERSONAL INFORMATION

We collect personal information in the following ways:

Directly from you if you:

- Make a donation
- Visit our website. Please see our Cookies section for more information;
- Sign up on our website to receive updates for one or more of our projects;
- Contact us with an enquiry;
- Are a church leader and/or have a key role in a church working in partnership with Pray Haringey

The personal information we collect:

- Contact details including postal address, post code, email and telephone number
- Financial information such as your bank details
- Whether you are a UK tax payer
- The event location where you signed up to our newsletter

Sensitive personal data

The Data Protection Act recognises some information as 'sensitive personal data'. This includes, but is not limited to, information which reveals your religious beliefs, health issues, race or ethnic origin.

Pray Haringey is a Christ-centred organisation committed to preserving its Christian ethos. Where necessary, and where consented to, we may collect details about your church affiliations and personal faith.

Additionally, we may collect details about any health concerns or disability. This is to allow us to make necessary arrangements if you are travelling overseas with us, or are working in any mission with us.

Pray Haringey will always treat any sensitive personal data we process with great care and process the information in accordance with the General Data Protection Regulation.

WHY WE COLLECT YOUR PERSONAL INFORMATION

- To process any donations.
- To reclaim tax on Gift Aid donations, if applicable.

• To verify that you are over 18 and if not, obtain permission from your parent/guardian to process your information or accept any regular donations.

• When you visit our website, we may gather information about which pages you visit to help us improve and provide you with the best service.

- To determine and improve the effectiveness of our website and marketing campaigns.
- To organise and coordinate Pray Haringey fundraising events
- To keep you informed about our work.
- To manage and coordinate our volunteers.
- For compliance with employment law and other statutory requirements.

CREDIT AND DEBIT CARD PAYMENT INFORMATION

When you make a donation to us online online, your details will be held securely by a third party. We will only see details of the sum which you have donated.

WHO WE SHARE YOUR INFORMATION WITH

Pray Haringey never sells information to other charities or organisations nor does it share information with organisations . Pray Haringey may use the Mailchimp or Wix email service to send you emails. Mailchimp and Wix are also bound by the General Data Protection Regulation. Please see their <u>privacy policy</u> for further information.

Pray Haringey may be under duty to disclose your personal information where required in order to comply with any legal obligation.

HOW LONG WE KEEP YOUR DATA

Pray Haringey will only keep your personal information for as long as it is required or in accordance with statutory requirements. For example, HMRC requires that we keep a record of your name,

address and Gift Aid declaration for six years from the date of your last donation. Where the information is no longer required, we will ensure that it is disposed of in a secure manner.

If you have indicated that you do not wish to hear from us in the future, we will keep the minimum information necessary to ensure we fulfil our legal obligations.

YOUR INFORMATION RIGHTS AND CHOICES

The General Data Protection Regulation (GDPR) gives you the right:

• To choose whether or not to receive marketing communication from us by email, text or telephone.

• To request in writing and securely obtain copies of the personal information Pray Haringey holds about you. Please see the <u>Information Commissioner's website</u> for regulations and exemptions.

• To correct or update your personal information processed by Pray Haringey.

• To request Pray Haringey to stop using your personal information for marketing purposes or for any other purpose where there is no legal requirement for continued processing.

The Privacy and Electronic Communications Regulations (PECR) gives you the right:

• To know about the cookies Pray Haringey uses, so that you can decide whether to give us permission to store a cookie on your device. Please see the Cookies section for more information.
